Here is a list of routine questions that may help in determining where a resident can go to find answers:



- 1. Neighbor is being vocally abusive, offensive language especially to children, coming onto private property to harass another neighbor: SAFFE Officer Shawn King at 210-207-7169.
- 2. Neighbors' house outside and lawn are filled with junk, cars that are not running or on blocks in the street, high grass and weeds in front of the property or along the back side of the fence facing a street-311.
- 3. Lifetime Management should be called at 210-504-8484 if the neighbor is keeping a trailer or junk vehicles in the driveway.

Water for Birds and other Wildlife

As the weather turns from warm to hot, it's important to remember that wildlife around us need water to survive. By adding a bird bath to your backyard, you can, eh um, 'kill two birds with one stone'. Birdbaths assist with providing



water to local wildlife and can be a great design feature too. If you have ever had the pleasure of watching a bird flutter around in a birdbath, then you know it's a joy to observe.

Adding any type of water feature to your backyard not only increases the value of your home, but also increases wildlife's chance for survival. Moving water features attract wildlife because the motion catches their eye, and they can hear the splashing of the water. Water features that move water also stay cleaner longer, meaning less time spent cleaning and changing the water and more time spent enjoying your new backyard paradise.

Birds, especially, need water for drinking and preening. On a hot day, water keeps their little body's cool from the inside out. As birds flutter around in the birdbath or water feature, they are removing parasites, dust, and other debris from their feathers. Adding medium-size rocks to the center of the bird bath allows baby birds to use it too.

Other wildlife such as deer, raccoons, squirrels, etc. also benefit from a birdbath or water feature in your backyard. These local animals will greatly appreciate a cool drink of water on a hot summer day. <u>WaterforWildlife.org</u> are working on projects across the United States to assist with this endeavor.
